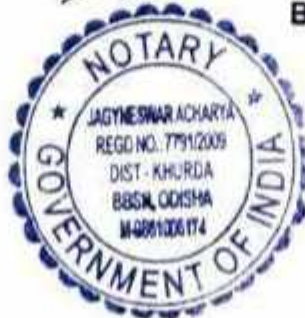

This request was accepted by him. Mr. Bairagi Charan Jena along with other member Mr. Kanhu Charan Nayak were inducted on 21.12.07.

NOW THE SAID DEED is reconstituted by inducing more like minded persons, reputed educationists interested to work for the furtherance of the objective of the Trust and for meeting requirement of statutory authorities and compliance of all acts, rules & laws of the land in force witness as follows.

- i) To confine objective of the Trust only to education.
- ii) To add Resolution clause for amendment / alteration of objectives.
- iii) To increase the number of Trustees for better functioning of the Trust.



Indumati Dei, do hereby stand and be possessed of the said sum of Rs 5,000/- (Rupees Five Thousand only) which shall constitute Trust Fund for registration purpose and provisions of these presents to be substituted or added in due execution of the Trust and powers of these presents (all which are herein after in these presents designated as "The Trust Fund") upon the Trust for the uses and subject to the provisions and directions and agreements here in after declared and contained in this DEED.

1. OBJECTS OF THE TRUST


The object of the trust shall continue to be as follows:

- (a) To support and promote the advancement of educational activities in all its branches, such as Kindergarten, Primary and High Schools, College leading unto and teaching Diploma, Degree, Post Graduate and Doctorate course in Arts, Science, Commerce, Engineering, Medicine, Pharmacy, Dental, Nursing, Nursery Teachers Education, Management, Music and Fine arts, Architecture and to impart industrial training and vocational training in the field of production & process, medical technology, science to develop other industrial activities and also such other subjects as the Board of Trustee may deem fit for the benefit of the Student of all castes and communities, both from India and outside.



- (b) To enter into technical and financial arrangement with national and international agencies and institution for exchange of knowledge by study tours, training in specialized area of science & technology, conducting joint projects, providing technical assistance in the establishment of scientific institutions and for other matters consistent with the aims and objectives of the trust.



- (i) To take such steps by personal or written appeals, or by advertisement otherwise, as may be deemed expedient, for the purpose of publishing the functions and activities of the Trust, or of procuring contributions to the funds of the Trust in the shape of donations, subscriptions or otherwise to make, enact, alter, amend, repeal, re-enact and enforce rules and regulations from time to time for the management and conduct of the work, business, departments, offices and affairs of the Trust, and in respect of qualifications, classes, conduct, functions, duties, remuneration and privileges of its works, institutions, activities or functions.
- (j) To negotiate and enter into the agreement with any government, University Municipality or any other public or private authority, which may seem conducive or beneficial, improved or rendered more efficient, work or activity of the Trust.
- (k) To purchase, take or lease or in exchange or otherwise acquire any movable or immovable property which may be deemed necessary, expedient, and desirable for any objects of the Trust.
- (l) To borrow money or receive money or deposit upon such terms, funds and assets of the Trust, as the Board of Trustees shall deem necessary or expedient for the objects of the Trust.
- (m) To enter into and carry out arrangement for joint, working or for amalgamation, with any other association, society, institutions or Trust, having objects within the objects of the Trust.
- (n) Generally to do all such other things as are deemed incidental or conducive to the attainment of all or any of the above objects

- (o) To take up such other activities as shall be mutually decided by the board of trustees from time to time looking at the need of time & people and /or in the interest of the nation.
- (p) The Trust shall be for the benefit of the institutions to be created by this Trust, and the institutions so created by this Trust shall be only beneficiaries.

2. TRUST FUND

- (a) The Managing Trustees shall stand the possessed of the said Trust fund upon Trust and also to receive any income or interest, dividends there of and voluntary contribution, donation and gifts and in the first place to reimburse themselves (other Trustee) or pay and discharge all the costs, charges and expenses incurred in or about incidental to the administration or execution of the Trust powers vested by these presents and also all outgoing taxes, rates assessments, dues, duties, levies and other taxes payable in respect thereof and the cost of meeting of ordinary repairs to any immovable property if for the time being subject to the trusts of these presents and subject there to upon trust to apply the residue of the said interest, divided and other income and at their discretion to utilize the whole or any part of the corpus of the Trust fund in India including promotion of education, culture, literature, art and science and definition of "Charitable purposes in section 2(15) of the Income Tax Act, 1961 as the Trustees may think fit and in such manner as the Trustees may think and for one or more such public charitable purposes as aforesaid so as not to violate the provisions of Income Tax Act, 1961. Provided that the said income as well as the corpus of the Trust Fund shall be utilized only towards education purposes as aforesaid in India and any accumulation of income shall also be made and deemed to be made for application to such education purposes as aforesaid in India in accordance with the provisions of Income Tax Act, 1961.

- (b) Without prejudice to the generality of the foregoing objects or purposes but subject to the aforesaid, it is declared that the Managing Trustees shall each year utilize the income of the Trust and may at their discretion at any time and from time to time utilize the Trust Fund in or towards any one of the objects of the Trust as mentioned in clause 1.

The surplus and un applied portion of the said income, if any, arising in any one or more year or years shall be accumulated and / or invested in accordance with the provisions of the income-Tax Act, 1961 as may be in force from time to time.

- (c) There shall be maintained all accounts of the Trust regularly, the accounts shall be audited a Chartered Accountant/government auditor every year.

3. POWERS & FUNCTIONS OF THE MANAGING TRUSTEES

- (a) The management and affairs of the Trust shall vest in all the Managing Trustees who will represent the Trust or its institutions before all courts and authorities, and exercise such powers as is necessary for conducting the affairs of the Trust ,or its institutions.
- (b) To decide all questions arising in the administration of the Trust hereof and including all questions relating to the interpretations of those presents, the administration of any institutions maintained by the Trust or concerning anything or any matter relating to or connected with or arising out of these presents or the operation thereof. The decision of the Managing Trustees on all or any other matters aforesaid shall be final.
- (c) To appoint and dismiss and reappoint executives, teaching staff, officials, engineers, doctors, nurses, clerks, care takers, attendants and other employees on such salary and on such terms as they may think fit.

- (d) To delegate by power of Attorney or otherwise by way of resolution to any Trustee or any other person or persons, powers and authorities implied by law or

conferred by statute or vested in the Trustees, the Trustee(s) shall, however, not be held liable or responsible for the acts or defaults of such authorized person.

- (d) To deposit by way of safe custody and documents held by them relating to any property belonging to the Trust with any bank and to pay any sum payable in respect of such deposit.

- (e) The Managing Trustees are hereby authorized to invite or accept donations of money, shares, debentures, bonds and the movable or immovable properties from the Author / Settler or any one else by way of gift, grant, legacy or otherwise on such terms and conditions as he may think fit not being inconsistent with the terms and conditions of these presents and such donations shall be held by the Managing Trustees as accretion and augmentation of the Trust Fund.

- (f) Whenever necessary the Managing Trustees may opt to retire or otherwise will have power to nominate his/her successor to be noted in the resolution of the board of Trustees and the successor so chosen will have all rights and liability like any other trustees. Such nomination may be changed from time to time.

- (g) The Managing Trustees will be solely responsible to purchase, construct, or hire or take on lease any immovable or movable property for all or any of the purposes of this Trust at such price, cost or rent and on such terms and conditions and for such period and with or without options for renewal as they deems fit. In case the immovable property owned by the Managing Trustees or, including the member Trustees, is taken on lease, the rent payable shall not exceed the fair market rent,

- (h) Where the Managing Trustees in the purported exercise of the Trusts discretion and power, hereby or by law conferred, act on the advice of any counsel, solicitor or other lawyer, engineer, surveyor, land or estate agent, actuary or broker, cashier or Accountant or expert, they or other trustee (s) shall not be responsible for any loss that may result from acting on such activities but the act or commission shall be deemed to be authorized and proper and the advice shall operate to protect the Managing Trustee & of commission had been directed or authorized under an order of a Court of competent jurisdiction.

The powers so vested will be exercised by the Managing Trustee(s) and such exercise of power will not invalidate any transaction.

- (i) The Managing Trustees are hereby vested with the power to open and operate Bank accounts as shall be decided from time to time by resolution and/or raise, borrow any amount of money from the banks or other as may be required by the Trust upon such terms as may be deemed fit by them.


- (j) The Managing Trustees are vested with the power to let out, lease, devise, mortgage, charge or license any property belonging to the trust for such rent or compensation and on such terms and conditions and for such period as they may think fit. the trusts and powers of these presents, including reasonable amount of traveling expenditure incurred for attending any activity of the Trust.

- (l) Upon any sale or other transfer by the Managing Trustees, under the power aforesaid the purchaser or purchasers, transferees(s) dealing bonafide shall not be concerned to see or inquire whether occasion for executing or exercising such power has arisen or whether the provisions as to the appointment and retirement of trustees herein contained has been properly and regularly observed and performed except that the decision to sell the properties has been taken in accordance with these presents. Neither shall the purchaser or purchasers, transferee or transferees be concerned to see to the application of the purchase money or other consideration thereof. The purchasers shall get a valid title in respect of properties purchased in good faith from the Managing Trustees.
- (m) Subject to any mandatory provisions of any law for the time being in force and applicable to the Trust, the Managing Trustees shall invest all moneys which shall require investment in any investments or properties of whatsoever nature and whatsoever situate and whether involving liabilities or producing income or not or upon personal credit with or without security and in the manner authorized by law and the income Tax Act, 1961 for the investment of the Trust funds and to call convert for exchange such investments and properties, both movable and immovable whenever, they in their absolute discretion, thinks it desirable to do so.
- (n) The Managing Trustees are vested with the power to decide all matters pertaining to admission of students of any Institute managed by this Trust and their decision in this regard shall be final, subject to the supervisory consent by the executive council of the institute.
- (o) To compromise, compound, abandon, submit to arbitration or otherwise settle any actions, suits, proceedings, debts, claims or things whatsoever arising out of the


administration of the Trust Fund, or any instruction maintained and for any of these purposes may enter into, give, execute and sign agreement, instruments, arrangements, releases and other things as may seem to him expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith as fully as in they were absolutely entitled to the Trust Fund and the said institutions without being answerable for any loss, occasioned in good faith.

- (p) The Managing Trustees will have all powers of Board of Trustees when the Board of Trustee are not in sitting in the meeting. They will exercise the powers of the Board of Trustees, in the absence of the member trustees or Board.
- (q) The Managing Trustees will be the manager of the institutions of the Trust , with the delegation of power of management to different executive council of different institutions.


4. TRUSTEES:

- (a) The number of the trustees including the managing trustees shall be not less than two and the board may appoint any number of member trustees whenever thought in the interest of the trust.
- (b) The managing trustees, the names of whom is mentioned shall be the life trustees and unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives. In case of death, the nominated person shall be the life trustee and the above provisions will apply to him/her also. In case of non-nomination, the legal heir(only one) shall automatically be the next life trustee of the trust.

- (c) A life trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
- (d) $\frac{2}{3}$ rd number of trustees shall form the quorum of a meeting of the trustees.
- (e) The managing trustee of the first part shall be the chairman of the board and in his absence, he may select another trustee to be the chairman of the board.
- (f) In case of difference of opinion among the trustees, the opinion of the majority shall prevail and in case of a tie, the chairman shall have a casting vote/opinion in addition to his opinion/vote.
- (g) No person being
- An undischarged insolvent; or
 - Convicted of offence involving moral turpitude; or
 - Of unsound mind;
 - A minor
- Shall be eligible to be a trustee.
- (h) A person shall cease to be a trustee in any of the following events:
- If he dies; or
 - If he becomes bankrupt; or
 - If he becomes insane or otherwise become incapable to act; or
 - If he resigns from his office.
 - If he retires from the office of the trustee

(i) The board of trustees may by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent
